Rates: Basic cost is \$275.00. You pay a \$100.00 non-refundable deposit when you reserve your date. This is for 200 people. One month before your scheduled event you send the balance, \$175.00. If you leave the pavilion in the condition you found it, you will receive \$50 back, unless you have chosen another option on the first page.

Up To 200 People - \$275.00 (Including \$100.00 Deposit)

201 Up To 400 People - \$350.00 (Including \$100.00 Deposit)

Arrival: Not before 10:00 AM

Departure: 11:00 PM on Saturdays
10:00 PM on Sundays (These times are strictly enforced)

Tables: Do not remove the tables from under the roof. If you wish to rearrange the tables, please do not drag them, pick them up and move them. Absolutely no thumbtacks or staples are to be used on the tables, please use masking tape.

Clean Up: Empty all garbage cans into the dumpster provided. Put new garbage bags (also provided) in the garbage cans.

Parking: Parking on Saturday – Park on the stone parking lot at the rear of the firehouse. DO NOT park on the blacktop lot, DO NOT park on the skating rink lot, DO NOT park on the road, and DO NOT park on the concrete pads in front of the firehouse. These areas are for fire truck use only.

Parking on Sundays - The first Sunday of the month is Bingo. On the first Sunday of each month please follow the parking rules for Saturdays. Any other Sunday you may park on the blacktop parking lot next to the firehouse or the stone lot at the rear of the firehouse. DO NOT park on the skating rink parking lot.

Parking Monday - Friday: Park on the blacktop lot or stone lot. DO NOT park on the skating rink parking lot.

Please remember do not block any roadways or intersections as fire trucks may need to get thru.

Water Usage: The Pavilion operates from a well. Water use is for cleanup only. Recreational uses, such as filling dunk tanks, water battles, etc., are not allowed.

Cancellation: If for any reason you must cancel and the date your reserved cannot be rebooked, you will not receive a refund. Ringling Hill Fire Co. is not responsible for cancellation due to a natural or man-made disaster, such as loss of electricity, etc.
